COOKIES POLICY FOR WEBSITES' VISITORS

1 → WHAT IS A COOKIE?



IT'S NOT A CAKE!

Cookies and similar trackers, such as "flash" cookies, "local storage", etc. (hereinafter referred to as "**cookies**") are files placed on a user's terminal when they use an application or visit a website. Cookies are used to store information on the user's terminal so that such cookies can be accessed later by the controller.

Some cookies are placed only for the duration of your browsing on an application or website (such as "session cookies", which disappear as soon as you leave the website concerned), while others are deemed "permanent" (i.e., they remain placed on your terminal until they expire, or even prior to the expiry if you delete them).



THERE ARE COOKIES TO SUIT ALL TASTES

HOW DO WE KEEP TRACK OF YOUR CONSENT COLLECTED?



Homa does not place cookies or other data on your computer without your consent, except for those cookies for which your consent is not required.

When you first visit our Websites, you will have the opportunity to accept or decline the use of cookies for which your prior consent is required. Where your consent is required, we will not place any cookies on your terminal until you have given your express consent.

If you do not wish cookies to be installed or read on your terminal, a refusal cookie will be stored on it so that we can keep track of your refusal. If you delete this cookie, we will no longer be able to know that you have refused the use of cookies. Similarly, when you accept cookies, a consent cookie is set. Consent or refusal cookies must remain on your terminal and are stored for a period of 6 months.

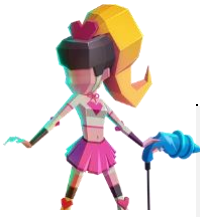

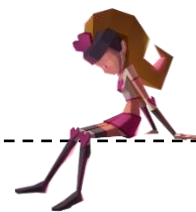
